The results of this study are that the process of sending goods through containers via train at PT Berkat Mandiri Logistik North Jakarta has several stages, namely making Delivery Orders, Making internal shipping and external shipping, Preparing empty containers, Transferring containers to cars, Making travel documents, Stuffing processes, Delivery to trains, Delivery to Surabaya, Dooring process.

# 1. INTRODUCTION

For each level of economic development, optimum transportation capacity is needed. However, it should be noted that determining the capacity and level of investment is not an easy matter. Transportation companies in order to meet the public's need for transportation services, in order to provide the best possible service to service users. For service users the priority is the matter of transportation which is safe, orderly, orderly, satisfying, fast and fun. In the operational system, there are 4 (four) process strategies, namely:

a. Intermittent production process.

Is an operational activity that uses production equipment that is arranged and arranged in such a way, which is used to flexibly produce various products and services.

b. Continuous production process.

Is a production process that uses production equipment that is arranged and regulated by providing sequences of activities in producing products or services, as well as the flow of materials in the process that has been standardized.

c. Repetitive production process.

Is a production process that uses the function of an intermittent production process and a continuous production process. But this process uses various parts and component materials, including a continuous process.

d. Mass production process.

Is a production process by combining the 3 (three) processes above which use various material components, use production schedule techniques and prioritize service speed. Generally this process is a business combination of goods and service products, as a spread in service operations (services).

Meanwhile, according to Barry Render and Jay Haizer in Supriyatin (2013: 53) in their book "Management of Production and Operations" defines there are 3 (three) process strategies, namely:

- a. Process focus. Processes that produce a few and varied products are now also known as disjointed processes. If the production equipment is arranged around the process, then it shows that they have a process focus.
- b. Product focus. A process with a large number of products but little variation is a product-focused process. The product equipment is arranged around the product. This process is also called a continuous process. The production run on this process takes a long time, and is continuous, as it's called.
- c. Focus on repeating processes. Production does not need to be below or above the extreme points of the process continuum, but may be a repeated process in the middle of the continuum. The process repeats using modules. Modules are parts or components that have been previously prepared, often in a continuous process.

According to Buchari Alma (2013: 237) in his book "Introduction to Business" defines the modern industry has developed several different types of production processes, namely:

a. Extractive process

The term extractive process refers to the method of extracting materials such as mining salt, coal, copper, zinc and so on. Several minerals such as magnesium, chlorine and sodium are taken from the sea. Nitrogen and Oxygen are taken from the air.

b. Process analysis

The analysis process includes breaking down the material into several products. For example oil mining after taking petroleum, flowing it, then separating it into gas, oil, asphalt, paraffin, and various other types of products.

The meat sales business also produces leather for the shoe factory. By-products can provide satisfactory sales results and become new jobs for the next factory.

c. Synthesis process

Synthesis means putting together. The process of synthesis means assembling various materials into a single product. This is the opposite of the analytical process, for example the production of rayon, rubber, and plastics, produced by synthesis. This process requires a variety of raw materials.

4. Fabrication process

In the process of fabricating raw materials are processed into different forms. Car manufacturers or aircraft manufacturers, using metal plates and formed into the fuselage or the body of the car. Through this fabricating, the process of changing shape is carried out so as to produce new goods.

#### 4. RESULTS AND DISCUSSION

- a. PT Berkat Mandiri Logistik cooperates with the Asahimas Company which provides goods delivery services every day through PT Berkat Mandiri Logistik. The Asahimas company provides Delivery Orders to the marketing division of PT Berkat Mandiri Logistik via email.
- b. After PT Berkat Mandiri Logistik received a Delivery Order, Marketing made internal and external shipping for booking trains via email. The function of internal shipping for the operational division is to carry out the process of preparing empty containers (empty containers) and the function of external shipping for the railroad is to book trains.
- c. After the internal shipping is received by the operational division, the next step is for the operations to take the empty container to the depot located in Kampung Bandan to check the physical condition of the container and to ensure that the container is fit for use, for example, not rusty, not smelly, not perforated and not dirty. The documents related to empty container retrieval are travel documents.
- d. After the container is suitable for use, the container operational division is upgraded to a trailer car.
- e. Next, the operational party makes a factory travel document. The travel document consists of three copies, namely: white for PT Berkat Mandiri Logistik, blue for Jakarta trailer drivers, green for Surabaya trailer drivers.
- f. Furthermore, the operational division submits a travel permit to the trailer driver to take the empty container to the Asahimas Company for stuffing. After the trailer driver arrives at the Asahimas Company, the trailer driver reports to security to enter the loading queue. Then the trailer driver gave a travel permit to carry out the stuffing process to the Asahimas Company warehouse. After the stuffing process was completed, the Asahimas Company warehouse handed over the goods to PT Berkat Mandiri Logistik.
- g. After the document handover process is complete, the next step is that the driver brings the container containing the load of goods to the Cikarang depot to transfer the container to the depot and the documents are handed over to the train, because the train departs once every two days so the cargo does not depart immediately.
- h. After the departure schedule arrives, the train provides confirmation of departure for containers ready to depart along with packing list documents and travel documents that will go to Surabaya to the marketing division of PT Berkat Mandiri Logistik via e-mail. Then marketing provides information to operations to notify the container that will be dispatched according to confirmation of departure. The process of train travel only takes 1x24 hours.
- i. After the train arrives at the waru surabaya depot, the next process is transferring the container to the trailer and submitting the documents to operations. After the operation of receiving the documents and transferring the container to the trailer is complete, the next stage is the process of sending the goods to the Asahimas Company in Surabaya. After arriving at the Asahimas Surabaya Company, the dooring process was carried out and the documents were submitted to the Asahimas Surabaya warehouse, dooring was the unloading of goods from the container. After the dooring process is complete, the original packing list and travel documents along with the warehouse signature are handed over to the operations of PT Berkat Mandiri Logistik and a copy of the packing list for the warehouse section of Ashimas Surabaya Company and the delivery process is complete.

# 5. CONCLUSION

Based on the analysis of the data obtained and the results of the research, it can be concluded that in the process of sending goods via containers via train at PT Berkat Mandiri Logistik North Jakarta, there are several stages, namely making delivery orders, making internal shipping and external shipping, preparing empty
